The Malaysian Institute of Chartered Secretaries and Administrators ("MAICSA", "we" or "us" or "our") and TARCIan Alumni Association(TAA) are required to comply with the Personal Data Protection Act 2010 (the "Act"), which regulates the processing of personal data in commercial transactions.
