GDPR, DATA SECURITY RISKS AND PROTECTION FOR ACCOUNTANTS

The rapid pace of technological change and globalisation have both profoundly transformed the scale and way personal data is collected, accessed, used and transferred. With more and more individuals worrying about their own personal data, especially in light of recent data breach headlines, organisations must ensure they are taking every measure to protect their data.

Not only are organisations facing increasing challenges to safeguard their data but pressure is on to comply with the new 'General Data Protection Regulation' (GDPR) that applies from 25 May 2018. This requires organisations not only to comply but also to demonstrate their compliance. Getting it wrong can be costly, with penalties of up to 4% of annual global turnover or €20m.

According to recent research by Beaming, more than half (52%) of British businesses fell victim to some form of cybercrime in 2016. It has been reported that 2.9m UK firms suffered cybersecurity breaches nationwide in 2016 at a cost of £29.1bn. In fact according to research carried out by Juniper Research the cost of cybercrime on global business could reach as much as \$2.1 trillion by 2019.

Today criminals will target any business regardless of size by exploiting weaknesses both internal and external. Understanding the weaknesses in your organisation is the best way to protect your business against fraud and cyber risk allowing you the opportunity to implement effective controls mechanisms before it is too late.

The aim of this session is two-fold:

- to provide an insight into stress
- to demonstrate practical techniques to increase an individual's resilience.

Although being a leader brings many benefits, it can mean being constantly 'on point' for prolonged periods of time. Although stress and pressure can be healthy, there is undoubtedly a fine line. When this line is crossed the cost to the individual and the team can be significant. It is therefore essential that individuals learn to adapt in the face of setbacks, remain focused when facing competing demands, and maintain a healthy balanced outlook.

Easier said than done – understanding you and your 'triggers' is the first step. From this we need to raise awareness of what resilience actually means and the intrinsic link that exists between thoughts, feelings and action. Then it's onto practical steps as to how you can take control of your working day.

17.00 – 18.15 COGNITIVE BIAS AND THE DARK SIDE OF LEADERSHIP

The aim of this session is:

- to raise awareness as to how ethical based decision making can be eroded
- to develop cognisance of cognitive bias, in order to understand the genesis of flawed decision making.

We all like to think that we lead in a rational ethical manner. We weigh up costs and benefits, consider differing courses of action and choose a solution which fits the needs of the team and the values of the business. We constantly make balanced, ethically sound decisions based on the facts available.

If only it was that simple – our decisions are not made by some autonomous system which is resistant to the surrounding environment and the influence of others. They are made by us, and with that are subject to a host of cognitive biases. These biases shape our recollection of the past, influence our present thinking and can result in deeply erroneous actions.

Very quickly the unjustifiable can become justifiable. If we understand how we are shaped, how we are susceptible to our environments, we can become better leaders. The scandals which have plagued business in recent years did not need to happen. This session is about understanding you, your culture and what needs to be done to safeguard the future.
