Notice of hearing

A hearing of ACCA's Disciplinary Committee will take place at 09:30am on 18 December 2024. It will be held remotely but based at the ACCA's Offices, The Adelphi, 1-11 John Adam Street, London, WC2N 6AU.

The case to be heard on this day concerns Mr Hemduth Ramchurun.

Allegations

- 1. Mr Hemduth Ramchurun, an ACCA student, in relation to his "FR" Financial Reporting exam sat on 7.9.2023:
 - (a) Used an unauthorised item, a mobile telephone with a camera, to take a photograph or photographs of his screen and live exam questions, contrary to exam regulations 5a, 5b and 11; and/or:
 - (b) Engaged in irregular conduct designed to assist him during the FR exam attempt, contrary to exam regulation 10; and/or
 - (c) Shared the said photograph or photographs with a third party or third parties contrary to exam regulation 13; and/or
 - (d) Failed to prevent the said photo or photographs from being accessed by or otherwise obtained by a third party or parties.

- 2. Mr Ramchurun's conduct in respect of allegations 1 (a) to (c) was:
 - (a) dishonest in that he took and/or shared the said photo or photographs to gain an unfair advantage in the said exam or a future FR exam; in the alternative:
 - (b) demonstrates a lack of integrity.
- 3. Further or in the alternative, Mr Ramchurun's conduct in respect of allegation 1(d) was reckless in that he knew that he should not store or otherwise retain ACCA exam content on his or any electronic devices yet nevertheless ran that risk.
- 4. By reason of the above, Mr Ramchurun is:
 - (a) Guilty of misconduct pursuant to bye-law 8(a)(i) in respect of any or all the conduct referred to above or, in the alternative:
 - (b) Liable to disciplinary action pursuant to bye-law 8(a)(iii) (in respect of allegations 1(a) to (c) only).

The allegations listed above are current at the date of publication.

The case will be heard by a panel of the ACCA's Disciplinary Committee.
