Notice of hearing

A hearing of ACCA's Disciplinary Committee will take place at 08.00am on 03 April 2025. It will be held remotely but based at the ACCA's Offices, The Adelphi, 1-11 John Adam Street, London, WC2N 6AU.

The hearing is open to any member of the public or the media who wish to attend. However, ACCA is only able to accommodate remote access to the hearing. Please contact <u>adminadjudication@accaglobal.com</u> to obtain information about attending this (or any other) hearing.

The case to be heard on this day concerns Ms Yun Hao.

Allegations

Ms Yun Hao, a student of the Association of Chartered Certified Accountants ('ACCA'):

- 1. During an TX examination held on 8 March 2022:
 - (a) Was in possession of unauthorised material, namely written notes (the 'Unauthorised Material'), contrary to Examination Regulation 4;
 - (b) Used, or attempted to use, the Unauthorised Material to gain an unfair advantage in the exam.
- 2. The conduct described in Allegation 1 was:
 - (a) Dishonest, in that Ms Yun Hao intended to gain an unfair advantage in her exam attempt; or in the alternative;
 - (b) Demonstates a failure to act with integrity.
- 3. By reason of her conduct, Ms Yun Hao is:

- (a) Guilty of misconduct pursuant to bye-law 8(a)(i); or in the alternative;
- (b) Liable to disciplinary action pursuant to bye-law 8(a)(iii), in respect of Allegation 1 (a) only.

The allegations listed above are current at the date of publication.

The case will be heard by a panel of the ACCA's Disciplinary Committee.
