1. MINUTES and ACTION LOG

The Board <u>approved</u> the minutes of the last meeting of the Qualifications Board held on 12 January 2024. The Board noted that there were no actions to follow up from the last meeting.

2. CONFLICTS OF INTEREST

No conflicts of interest were declared.

3. EXAMINATION RESULTS GOVERNANCE REVIEW

The Board noted the Exams Governance Report which had been circulated to the Board. The Board received a presentation from the Director – Professional Qualifications and the Qualifications Data Science Lead on the delivery of exams and the results of the March 2024 exam session.



The Board also received an oral report from the Chief External Examiner on her review of the exam papers, confirming the following:

- It was confirmed that all exams were comparable in standard and there were no overlaps.
- All papers covered various interesting and relevant scenarios with an appropriate mix of style and diversity with the criteria met.
- The rigorous analysis of exam results provides integrity to the process.
- That there were no aspects of the exams that gave her cause for concern and that she was satisfied with all aspects.

Based on the evidence presented and subsequent discussion, the Board <u>agreed</u> to ratify the March 2024 examination results.

4. LEAD REGULATOR UPDATE

The Board noted the update on ACCA's interactions with its lead regulators from the Head of Education Recognition.

5. ACCA WIDE DEVELOPMENTS - STRATEGY

The Board received an update on ACCA's strategy including the strategic priority for the year from the Director - Strategy.
