### **ACCA Community Day 2025 Concludes in Success**

***Financial accounting elites come together to deliver love through rickshaw race and shape a brighter future***

**ACCA (the Association of Chartered Certified Accountants) Hong Kong** concluded its **ACCA Community Day** today at Chater Road, Sunday Pedestrian Precinct, Central. As one of the major finance and charity events in 2025, **Paul Chan Mo-po**, the Financial Secretary of the HKSAR government, has been invited as the guest of honour. The event attracted participants from accountancy firms, multinational companies, local organisations, and institutions, coming together in a spirit of unity and compassion to demonstrate social responsibility. After a thrilling competition, Team EY Tax claimed the victory in the rickshaw race.

This year's event celebrates the 75th anniversary of ACCA in Hong Kong, centred around the theme '**75 Years in Hong Kong: A relay of love for a better future**'. It showcases how ACCA has united the local accountancy industry, nurtured local accounting talent, and remained steadfast in its commitment to advancing public welfare, fostering social harmony, and contributing to Hong Kong's prosperity and sustainable development over the past 75 years.
